

STUDENT VISA (SSU or SLU)

All Criminal Records, Medical Certificates and Civil Registry certificates that have not been issued by a Spanish Authority must be translated into Spanish and apostilled.

All documents must be originals. If you wish to keep the original documents, you must provide a copy them.

REQUIREMENTS:

1. **National Visa Application Form**, duly completed.
2. **One recent passport-size photo** with a white background affixed to the application form.
3. **Valid passport or travel document**, recognized as valid in Spain, with a **minimum validity of one year**.
4. **One photocopy** of the data page of the current passport.
5. **Letter of admission** from the corresponding university, institution, or study center, including details of the course, training calendar, study program, etc.
6. **Proof of financial means/solvency:** Bank certificates showing account transactions for **at least the last six months**.
7. **Public or private health insurance** contracted with an insurance company authorized to operate in Spain.

IF THE DURATION OF STUDIES IS LONGER THAN SIX MONTHS (SLU)

The applicant must additionally submit the following documents:

14. **Medical Certificate:** Original and translation, of a certificate confirming that the applicant does not suffer from any disease that could have serious repercussions for public health, in accordance with the *International Health Regulations of 2005*. The original must be **apostilled by the Philippine Department of Foreign Affairs (DFA)** and **valid for three months** from the date of issuance.
15. If the applicant is over 18 years of age, **Criminal Record Certificate (NBI):** Original and translation of the certificate issued by the **National Bureau of Investigation (NBI)**, apostilled by the **Philippine Department of Foreign Affairs (DFA)**, valid for **six months** from the date of issuance, as well as certificates from any countries where the applicant has resided during the past **five years**, duly legalized by the corresponding authorities.

SPECIFIC DOCUMENTATION FOR MINORS TRAVELING ALONE

1. **Notarized authorization from parents** allowing the minor to travel, and the **child's birth certificate (PSA/NSO)**.
2. **Letter from the legal guardian in Spain**, authorizing the consultation of their personal data in the **Central Registry of Sexual Offenses**.

1. **Notarized declaration** from the person who will act as the legal guardian in Spain, **accepting guardianship of the minor**. The document must include:
 1. Full name, ID (DNI), and address of the guardian.
 2. Notarized copy of the guardian's ID (DNI).
 3. Dates during which the guardianship will be exercised.
 4. The minor's residence address in Spain.

3. If the minor is traveling to Spain **to study under programs promoted and funded by the Spanish Administration**, or by **non-profit associations, foundations, or other entities/persons not holding parental authority or guardianship**, a **favorable report** issued by the **Government Delegation or Sub-delegation** of the province where the minor intends to reside in Spain is required.

NOTE: Additional documents may be required.
