RESIDENCE VISA (PETITION)

(For spouses, children (below 18 years) or parents of
Filipinos with residence permits in Spain)

PROCEDURE:

1. Complete the documents required. Put all the documents in 1 large brown envelope (with the applicant's surname, name and contact number written in bold letters on the upper left corner of the envelope).
2. The applicant must come personally on the appointment date and must pay the visa fee upon submission of the application.
3. Always include 2 photocopies of the filled-up application form and 1 photocopy of the rest of the documents.

REQUIREMENTS:

1. Duly accomplished **National** application form.
2. One (1) recent passport-size photo with white background (to be pasted on the application form)
3. Valid passport (with validity of at least 4 months).
4. **1 photocopy** of the data page of the valid passport.
5. Copy of the "**Autorización de Residencia**" issued by the Spanish authorities.
Note: The applicant has to apply for the visa within the 2-month validity period of the "autorización de residencia", from the date of receipt of the petitioner of the said document.
6. Copy of the residence card of the petitioner.
7. **LITERAL CERTIFICATE OF LIVE BIRTH** and **LITERAL MARRIAGE CONTRACT** (if applicable) of the applicant and the petitioner, issued by the Philippine Statistics Authority (PSA) on security paper and authenticated by the Department of Foreign Affairs (DFA).
- If delayed / late registration, include Negative Certification from the Local Civil Registrar, Baptismal Certificate, School Records (from DECS) and Hospital Records of pregnancy & birth/delivery.
8. **Medical Certificate** (done at any DOH accredited hospital or clinic) authenticated by the Department of Foreign Affairs, indicating the non-existence of diseases that may have a serious effect on public health, according to International Sanitary Regulations of 2005 (authenticated by the Department of Foreign Affairs) (validity 3 months from date of issuance).
9. **NBI Clearance** (National Bureau of Investigation) authenticated by the Department of Foreign Affairs (validity is 3 months from date of issuance).
10. **Minors:** Authorization of consent from parents.
11. All documents presented must be translated by a recognized Spanish translator (traductor jurado) accredited by the Spanish Ministry of foreign Affairs.

NOTE: OTHER DOCUMENTS NOT INDICATED MAY BE REQUIRED
